Dear Executive Director/Public Housing Provider:

The New Jersey Department of Community Affairs is required to report certain information on violent crimes and drug offenses to the State Legislature by January 1, 2014. The report provides the number and type of violent crimes and drug offenses that occurred during the preceding State fiscal year, July 1, 2012 through June 30, 2013.

Executive Directors of housing authorities and owners of project-based housing of ten or more units in New Jersey are required to provide this data to the Department of Community Affairs no later than September 1st of each year on a form provided by the Department for this purpose.

Attached is a copy of the report form to be completed and returned to us. A separate form should be used for each housing development. You should be able to obtain the crime data from your local police department. If you are unable to comply with this requirement, please provide us with a letter stating the reasons why.
