FINGERPRINTS MUST BE TAKEN BY LAW ENFORCEMENT PROFESSIONALS

WE HAVE FOUND THAT FINGERPRINTS TAKEN BY NON-LAW ENFORCEMENT PERSONNEL ARE OFTEN IMPROPERLY TAKEN, FORCING US TO RETURN THEM TO THE PERSON SUPPLYING THEM FOR A PROPERLY TAKEN SET, THEREBY RESULTING NOT ONLY IN INCONVENIENCE TO THAT PERSON, BUT DELAY IN PROCESSING OF THE APPLICATION. ALL SECTIONS MUST BE COMPLETED ON CARDS.

IF YOU LIVE OR WORK IN NEW JERSEY:

NEW JERSEY HAS CHANGED FROM THE TRADITIONAL "INK AND ROLL" METHOD TO THE "LIVE SCAN METHOD" FOR INDIVIDUALS WHO WORK OR RESIDE IN NEW JERSEV OR THE SURROUNDING AREA. IF YOUR ZIP CODE IS LISTED BELOW YOU WILL BE LIVE SCANNED AT A LOCATION BY YOUR OFFICE OR RESIDENCE AFTER YOU HAVE SUBMITTED YOUR APPLICATION AND PAID THE APPLICATION FEE. YOU WILL RECEIVE INSTRUCTIONS FROM THE NEW JERSEY STATE POLICE ON THE FINGERPRINTING PROCEDURES. PLEASE REVIEW THE ZIP CODE LIST BELOW:

FINGERPRINT PROCESS FOR OUT-OF-STATE APPLICANTS

Applicants have <u>two options</u> for submitting their fingerprints - LIVESCAN <u>OR</u> CARDSCAN: (Read both options before selecting)

OPTION A: LIVESCAN/If an available IDEMIA UEP Location is in your area (<u>More</u> convenient but at an additional cost of \$39.95 plus applicable tax, paid by the applicant at time of service):

- Go to this website https://uenroll.identogo.com/
- Enter Service Code **2F1HH4**, click **GO**
- To check for an enrollment center by you, click on **Locate an Enrollment Center**, enter zip code and search. If you find a location, click Done
- Click on Schedule or Manage an Appointment
- Follow the prompts and start completing the pre-enrollment screens
- When prompted under Additional Information tab, Agency Identifiers, Contributor Case Number, your <u>Contributor Case # is 1921</u> (there is no Miscellaneous # - Leave Blank)
- Continue to follow prompts/questions until the Location Page
- Type in your ZIP code or City and State to search for Enrollment Centers near you, click Search

- Click on a location of your convenience and continue to schedule your appointment.
- When you select Submit, you will see a Service Summary (Print Out/Upper Right Corner) You will receive an email or confirmation number when registration is complete.
- (The UE ID will begin with UZNJ-#####, please retain this identified to assist with future follow up, if needed)
- Remember to bring the identification that you selected to utilize and any other identification you may have been requested to bring. Identification must be valid, not expired, and contain a photograph.
- ***Reminder, you will be asked at the enrollment center to pay an additional \$39.95 plus applicable tax for this convenience
- IMPORTANT !! ***ATTACH a copy of your receipt, after being fingerprinted, to your Personal History Disclosure Statement which you are submitting to Division of Law

OR

OPTION B: CARDSCAN/SUBMITTING FINGERPRINT CARDS

- Applicants are provided the enclosed fingerprint cards 2 BLUE FINGERPRINT CARDS NEEDED
- Applicants are required to go to a local law enforcement department/an authorized authority to be fingerprinted either the traditional `ink & roll' method or use the electronically scanned fingerprints and transpose them onto the fingerprint cards
- Ensure your cards are signed and dated by the law enforcement officer/authorized personnel
- Applicants will complete all personal information and **sign** the fingerprint cards. Additional information needed for cards:
- Reason Fingerprinted A901 Licensing/NJSA 13:E-126
- Your No. OCA 1921
- Universal Control No. UCN Leave Blank
- Armed Forces No. MNU Leave Blank
- Miscellaneous No MNU Leave Blank
- Applicant will then Pre-enroll the fingerprint cards for **Cardscan** submission at https://uenroll.identogo.com/ to initiate a **Cardscan** submission
- Enter Service Code **2F1HH4**, Click Go

- Click on Submit A Fingerprint Card by Mail (you will then see an 'Attention box', READ and then click Continue
- Follow the prompts to complete the pre-enrollment screens (**Personal** information entered should match the information on your fingerprint cards)
- Under Additional Information tab, Agency Identifiers, enter the following
- Contributor Case #, your <u># is 1921</u>
- Miscellaneous # Leave Blank
- Continue to follow prompts/answer questions. After you answer alias and mailing address questions, enter NO to locating a center to be livescan
- If you are submitting fingerprint cards, click Next and continue to enter personal information
- Click Next, enter mailing address again, then press Submit
- The next page (Bar Code page) you are <u>REQUIRED</u> to Print, SIGN, fill in Section 3 and submit both pages with your fingerprint cards along with your Personal History Disclosure Statement to New Jersey Division of Law (keep a copy for yourself) DO NOT MAIL TO IDENTOGO IN FRANKLIN, TN
- At this point, you can click Done

NEW JERSEY STATE POLICE

THE RECORD IS SUBJECT TO THE FOLLOWING USE AND DISSEMINATION RESTRICTIONS

THIS PRIVACY ACT STATEMENT SHOULD EXPLAIN THE AUTHORITY FOR COLLECTING YOUR INFORMATION AND HOW YOUR INFORMATION WILL BE USED, RETAINED, AND SHARED.
- IF YOU HAVE A CRIMINAL HISTORY RECORD, THE OFFICIALS MAKING A DETERMINATION OF YOUR SUITABILITY FOR THE EMPLOYMENT, LICENSE, OR OTHER BENEFIT MUST PROVIDE YOU THE OPPORTUNITY TO COMPLETE OR CHALLENGE THE ACCURACY OF THE INFORMATION IN THE RECORD.
- THE OFFICIALS MUST ADVISE YOU THAT THE PROCEDURES FOR OBTAINING A CHANGE, CORRECTION, OR UPDATE OF YOUR CRIMINAL HISTORY RECORD ARE SET FORTH AT TITLE 28, CODE OF FEDERAL REGULATIONS (CFR), SECTION 16.34.

IF YOU HAVE A CRIMINAL HISTORY RECORD, YOU SHOULD BE AFFORDED A REASONABLE AMOUNT OF TIME TO CORRECT OR COMPLETE THE RECORD (OR DECLINE TO DO SO) BEFORE THE OFFICIALS DENY YOU THE EMPLOYMENT, LICENSE, OR OTHER BENEFIT BASED ON INFORMATION IN THE CRIMINAL HISTORY RECORD.

YOU HAVE THE RIGHT TO EXPECT THAT OFFICIALS RECEIVING THE RESULTS OF THE CRIMINAL HISTORY RECORD CHECK WILL USE IT ONLY FOR AUTHORIZED PURPOSES AND WILL NOT RETAIN OR DISSEMINATE IT IN VIOLATION OF FEDERAL STATUTE, REGULATION OR EXECUTIVE ORDER, OR RULE, PROCEDURE OR STANDARD ESTABLISHED BY THE NATIONAL CRIME PREVENTION AND PRIVACY COMPACT COUNCIL.

IF AGENCY POLICY PERMITS, THE OFFICIALS MAY PROVIDE YOU WITH A COPY OF YOUR FBI C1IMINAL HISTORY RECORD FOR REVIEW AND POS-SIBLE CHALLENGE. IF AGENCY POLICY DOES NOT PERMIT IT TO PROVIDE YOU A COPY OF THE RECORD, YOU MAY OBTAIN A COPY OF THE RECORD BY SUBMITTING FINGERPRINTS AND A FEE TO THE FBI. IF YOU DECIDE TO CHALLENGE THE ACCURACY OR COMPLETENESS OF YOUR FBI CRIMINAL HISTORY RECORD, YOU SHOULD SEND YOUR CHALLENGE TO THE AGENCY THAT CONTRIBUTED THE QUESTIONED INFORMATION TO THE FBI. ALTERNATIVELY, YOU MAY SEND YOUR CHALLENGE DIRECTLY TO THE FBI. THE FBI WILL THEN FORWARD YOUR CHALLENGE TO THE AGENCY THAT CONTRIBUTED THE QUESTIONED INFORMATION AND REQUEST THE AGENCY TO VERIFY OR CORRECT THE CHALLENGED ENTRY. UPON RECEIPT OF AN OFFICIAL COMMUNICATION FROM THAT AGENCY, THE FBI WILL MAKE ANY NECESSARY CHANGES/CONCLUSIONS TO YOUR RECORD IN ACCORDANCE WITH THE INFORMATION SUPPLIED BY THAT AGENCY.
