#### **Our Mission Statement:**

- Maintains a toll-free help-line and Web site to assist the public and records custodians
- Issues advisory opinions on the accessibility of government records
- Delivers training on the law
- Provides mediation of disputes about access to government records
- Resolves disputes regarding access to government records

#### The purpose of this report:

This report provides a statistical analysis of the Government Records Council's production during Fiscal Year 2012. Specifically, this report demonstrates:

- The number of Denial of Access Complaints filed in Fiscal Year 2012;
- The number of Denial of Access Complaints adjudicated in Fiscal Year 2012;
- The types of decisions issued by the Council;
- A breakdown of the Council's monthly adjudications; and
- The number of inquiries resolved by the Council in Fiscal Year 2012.

Additionally, the Appendix section of this report provides the background data used in this statistical analysis.

#### **Definition of Terms:**

The following words and terms, when used in this report, shall have the following meanings:

**Adjudication**: Formal action by the Government Records Council regarding the merits of a Denial of Access Complaint in which a requestor claims that a custodian has unlawfully denied the requestor access to a government record.

**Council Decision**: An official, written decision of the Government Records Council regarding the merits of a Denial of Access Complaint. The Council issues three (3) types of decisions:

- 1. Administrative Dispositions are decisions of the Council as to whether to accept or reject the Executive Director's recommendation of dismissal based on jurisdictional, procedural or other defects of the complaint.
- 2. **Interim Orders** are orders issued by the Council requiring the records custodian or the complainant to perform some act in accordance with OPRA, the compliance of which must be reported back to the Council.
- 3. **Final Decisions** are decisions of the Council as to whether to accept or reject the Executive Director's recommendation of dismissal based on applicable statutory, regulatory, or other legal authority.

**Denial of Access Complaint**: A formal complaint submitted to the Council on a form authorized by the Council in which a requestor claims that a custodian has unlawfully denied the requestor access to a government record.


**Inquiry**: A request from the public or a custodian, submitted to the Council in writing or from the toll-free helpline, for information regarding or assistance with the Open Public Records Act, the Council, and issues and matters regarding access to government records.

#### **Denial of Access Complaints Filed in Fiscal Year 2012**





#### **Denial of Access Complaints by Agency Type**


The GRC receives Denial of Access Complaints filed against various types of government agencies. Below is a breakdown of the types of agencies represented in the 355 Denial of Access Complaints filed in FY 2012.





#### **Denial of Access Complaints Filed and Closed in FY 2012**

Of the 355 Denial of Access Complaints filed in FY 2012, 106 complaints (30%) were fully adjudicated and closed by the end of the fiscal year. 249 complaints (70%) remained open. Of the 249 open complaints, 2 complaints were adjudicated once but remained open for further action by the Council.



#### Average Adjudication Time: Complaints Filed and Closed in FY 2012


On average, the GRC adjudicated and closed the 106 complaints described above in 75.5 calendar days.

#### **Total Complaints Adjudicated in FY 2012**

The GRC adjudicated a total of 458 complaints in FY 2012 (of which 106 complaints were opened and closed in FY 2012 as described above). Important: this number does not reflect 458 separate complaints, but rather 458 adjudications. The 458 adjudications encompassed 338 new complaints, and 120 complaints which the Council previously adjudicated at least once (55 of which were previously adjudicated during the 2012 fiscal year).


#### Average Adjudication Time: First Adjudications

Out of the Council's 458 complaint adjudications in FY 2012, 338 complaints were adjudicated for the first time (if not closed) during FY 2012. On average, the GRC adjudicated the 338 complaints in 341 calendar days from the date of filing. Important: this number does not include the complaints identified below, which were prepared for adjudication prior to FY 2012 but were not adjudicated until FY 2012 due to a lack of quorum on the Council.




Averages: The GRC received an average of 30 complaints per month and adjudicated an average of 42 complaints per month.








Below is a breakdown of the number and percentage of complaints that were closed, or remained open after the Council's September 27, 2011 meeting:












Below is a breakdown of the number and percentage of complaints that were closed, or remained open after the Council's October 25, 2011 meeting:









Below is a breakdown of the number and percentage of complaints that were closed, or remained open after the Council's November 29, 2011 meeting:




Below is a breakdown of the number and percentage of complaints that were closed, or remained open after the Council's December 20, 2011 meeting:






**January 31, 2012 Council Meeting**: The Council adjudicated 46 complaints. Below is a breakdown of the types of decisions issued:


Below is a breakdown of the number and percentage of complaints that were closed, or remained open after the Council's January 31, 2012 meeting:






**February 28, 2012 Council Meeting**: The Council adjudicated 48 complaints. Below is a breakdown of the types of decisions issued:


Below is a breakdown of the number and percentage of complaints that were closed, or remained open after the Council's February 28, 2012 meeting:






March 27, 2012 Council Meeting: The Council adjudicated 58 complaints. Below is a breakdown of the types of decisions issued:


Below is a breakdown of the number and percentage of complaints that were closed, or remained open after the Council's March 27, 2012 meeting:




Below is a breakdown of the number and percentage of complaints that were closed, or remained open after the Council's April 25, 2012 meeting:




Below is a breakdown of the number and percentage of complaints that were closed, or remained open after the Council's May 29, 2012 meeting:







#### **Inquiries Resolved in FY 2012**

The GRC operates a toll-free inquiry hotline to which requestors of government records and records custodians may call to obtain guidance regarding the Open Public Records Act. The toll-free number is 1-866-850-0511. Additionally, the GRC can be reached by e-mail at grc@dca.state.nj.us.

In FY 2012, the GRC successfully completed 2,636 inquiries from records requestors, records custodians, and public agency attorneys. This amounts to an average of 10 inquiries per working day (based on a 261 work day calendar).
