



**Minutes of the Government Records Council
January 26, 2021 – Closed Session**

The Council convened in closed session at 1:36 p.m. telephonically. In attendance were: Robin Berg Tabakin, Esq. (Chairwoman), Jennifer Simons Esq. (designee of Department of Education Acting Commissioner, Dr. Angelica Allen-McMillan), Gina Trish (designee of Department of Community Affairs Commissioner, Lt. Governor Sheila Y. Oliver), and Steven Ritardi, Esq. (Public Member)
