Paff v. Township of Plainsboro (2005-29)

It was noted that the case is on appeal. Legal advice provided to Council on the Complainant counsel's Motion to Settle the Record as it pertained to this case.

Meyers v. Borough of Fair Lawn (2005-127)

It was noted that the case is on appeal and the Custodian is requesting a stay of the Council's order for disclosure of records responsive to the request pursuant to OPRA. Discussion of legal strategy regarding the anticipated litigation. The Council received legal advice on the request for a stay of the Council's order and the legal standards required in a request for a stay.

Paff v. Bergen County (2005-115)

Vincent Maltese recused himself from discussion in this case.
