Dear Mr. Gasero:

The New Jersey Department of Health and Senior Services (the Department) is in receipt of a copy of a Consent Order (copy enclosed) entered in the above referenced matter and signed by the Honorable Dennis V. Nieves, J.S.C., on July 19th, 2007. Pursuant to the terms of the Consent Order, you agreed to permanently surrender your EMT-Basic certification and are permanently prohibited from providing basic life support (BLS) ambulance services on either a paid or voluntary basis.

In accordance with N.J.A.C. 8:40A-7.1(f), certification cards are the property of the Department and shall be immediately surrendered upon demand. You are hereby directed to immediately surrender your EMT-Basic certification card to the Office of Emergency Medical Services (OEMS), either by U.S. mail to the address above or by personal delivery to OEMS at Capitol Plaza, 50 E. State Street, 6th Floor, Trenton, N.J.

Please be advised that the OEMS has just implemented a new automated system for generating certification cards and that, in the near future, you may receive a new certification card in error. In addition to your existing certification card, you must also surrender any new certification card that may be sent to you in error as the automated system is brought online. 
And defendant Matthew Gasero consenting to this Order as a condition of his admission into the Pretrial Intervention Program, and for good cause shown,
