
On November 13, 2020, the Department of Health (Department) issued an Emergency Curtailment of Admissions Order and Directed Plan of Correction (DPOC), which was amended via a separate Order dated December 11, 2020. The DPOC required the facility to retain the full-time services of a Certified Infection Control Practitioner (ICP) consultant.

As of today, January 6, 2021, the Department is hereby lifting the December 11, 2020 Emergency Curtailment of Admissions Order. The requirements related to the Directed Plan of Correction shall remain in place until the Facility is otherwise notified in writing by a representative of this Department. Please also be advised that Department staff will monitor Facility compliance with this order to determine whether corrective measures are implemented by the Facility in a timely fashion.
