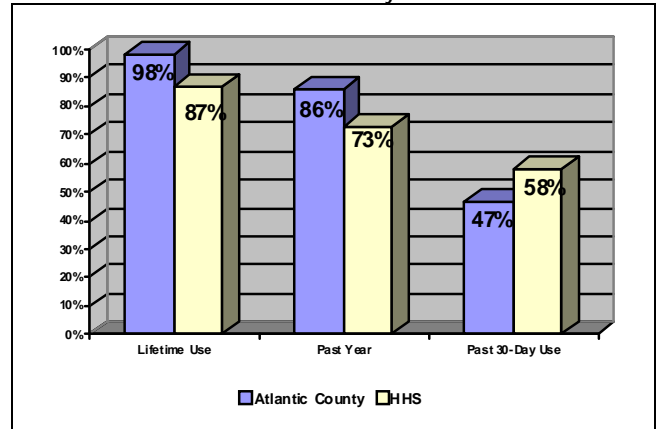


Data were collected on 939 clients in 2009 who went through the Atlantic County Intoxicated Driver Resource Center program or were monitored by the Atlantic County IDRC. 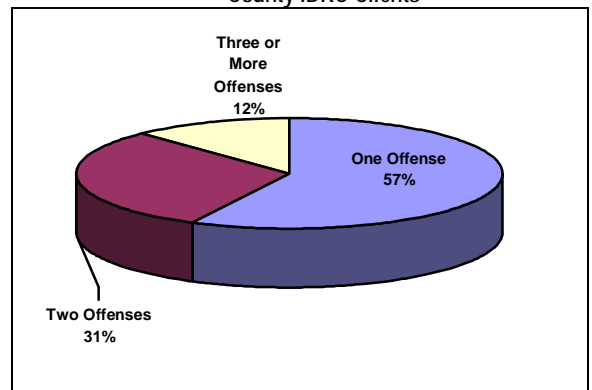

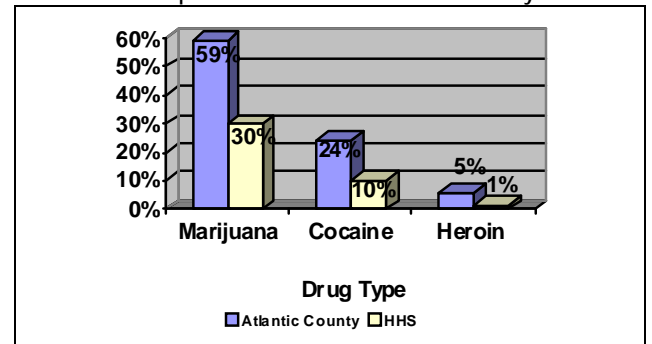
Alcohol Use by Atlantic County IDRC Clients Compared with 2003 NJ Household Survey



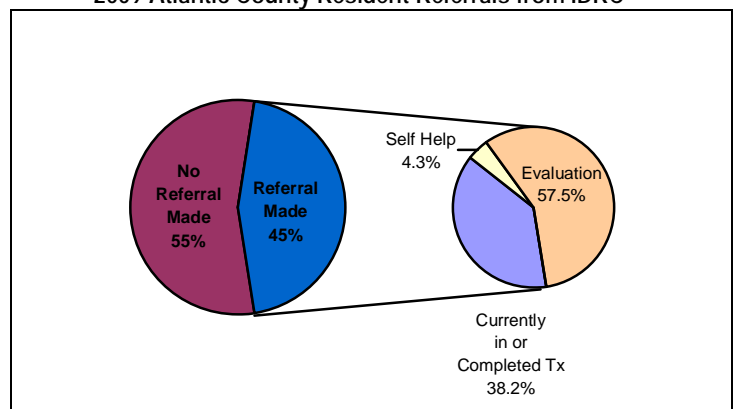
Number of Alcohol-Related Offenses on DMV Records of Atlantic County IDRC Clients

2009 Atlantic County Resident Referrals from IDRC



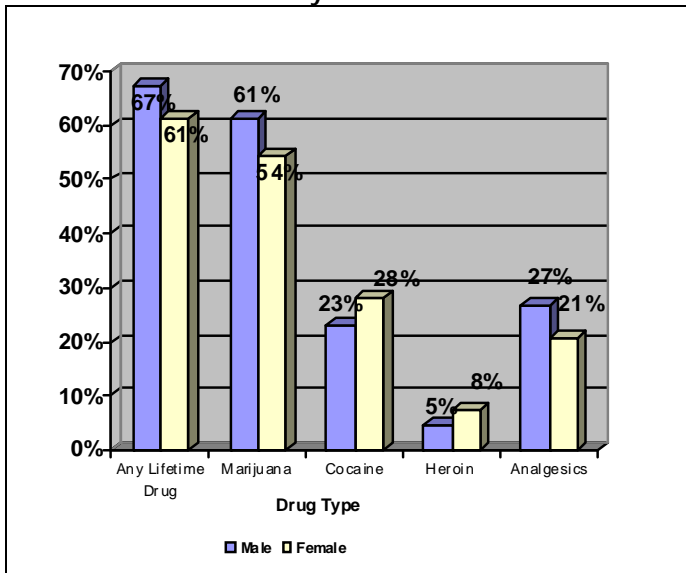
