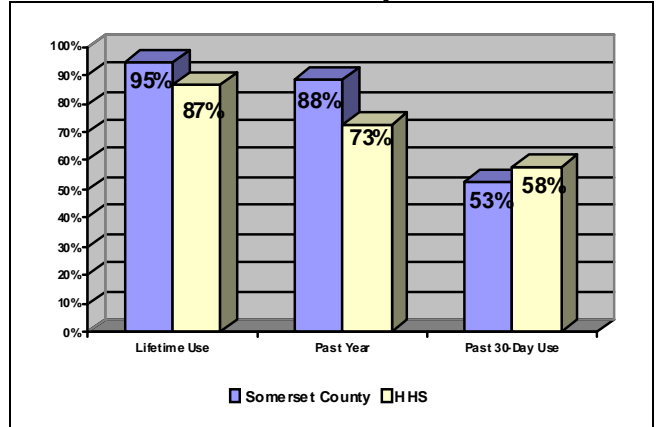


Data were collected on 863 clients who went through the Somerset County Intoxicated Driver Resource Center program in 2009 or were monitored by the Somerset County IDRC. 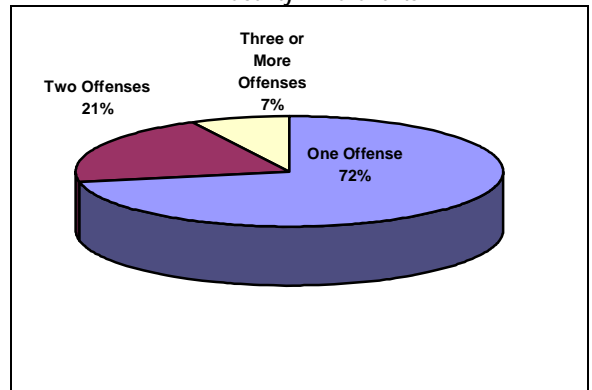

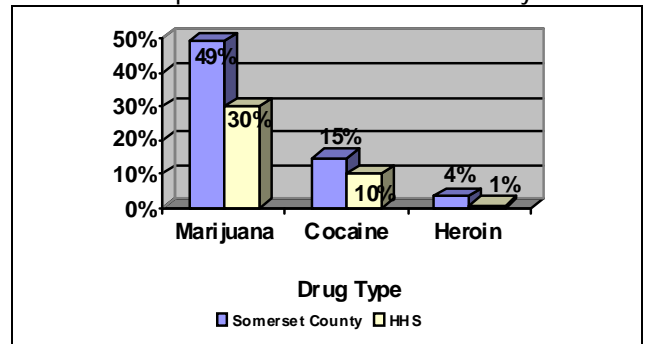
Alcohol Use by Somerset County IDRC Clients Compared with 2003 NJ Household Survey



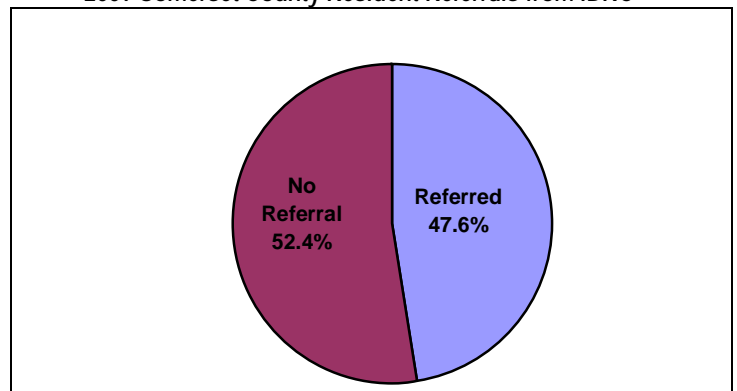
Number of Alcohol-Related Offenses on DMV Records of Somerset County IDRC Clients

2009 Somerset County Resident Referrals from IDRC



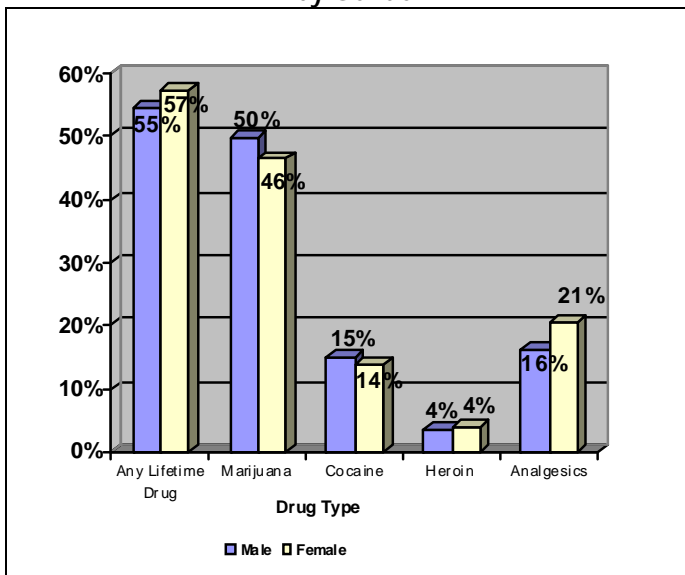
