**Annual Report on Access to Employer-Based Health Insurance**

**Background**

In August 2006, legislation was enacted (P.L. 2006, c.87) directing the Commissioner of the Department of Human Services (DHS) to prepare an annual report on Access to Employer-Based Health Insurance for NJ FamilyCare (NJFC)/Medicaid enrollees.

The purpose of this report is to identify those employers, with 50 or more NJFC/Medicaid enrollees, in the State whose employees and their dependents do not have access to employer-based health insurance coverage and receive, instead, insurance coverage through the publicly-funded NJFC/Medicaid program.

**Data Report Source**

The Department of Labor and Workforce Development (LWD) utilized their database to match against a file containing NJFC/Medicaid enrollee social security numbers provided by DHS' Division of Medical Assistance and Health Services (DMAHS). The file utilized by the Department of Labor was not collected for the intent of producing this report.

It is important to note again this year, that there are limitations inherent in the information available for this report. The LWD file does not contain enrollee quarterly income or number of hours worked. As a result, the report cannot provide information on whether an employee is full-time or part-time or how long the employee has been employed with a particular employer. The report illustrates a "period of time" (April 1, 2011 to June 30, 2011) and is a representation of what the employment picture looks like for certain NJFC/Medicaid enrollees in New Jersey.

Although the enabling legislation calls for the employer's address or work site, the data source utilized does not list individual employment sites. Instead the data file provides an address directly related to each tax identification number which may be a corporate site or a payroll vendor. For this report, the tax identification number is listed for each employer.

**NJ FamilyCare**

NJFC/Medicaid provides free or low cost comprehensive health insurance for uninsured children and certain low income parents. This program is both state and federally funded and eligibility is based on income and household size. Children can be eligible with household income up to 350% of the federal poverty level (FPL). As the result of a law in New Jersey (P.L. 2008, c.38), effective September 1, 2008, the income standard

for uninsured parents/caretakers increased from 133 percent to 200 percent of the FPL which, for a family size of four, is \$44,700 annually<sup>1</sup>.

In most instances, to be eligible for NJFC/Medicaid, the enrollee must have been uninsured for three months. While there are a few exceptions to this rule, such as the family lost health insurance through no fault of their own, i.e., the parent was laid off, higher income families cannot drop employer sponsored health care coverage to access NJFC/Medicaid.

### **Data Report Summary**

The data shows that there are 440 employers in New Jersey with 50 or more NJFC/Medicaid enrollees. They employ a total of 62,291 employees (see Column A of Table 1) who are receiving health care coverage through NJFC/Medicaid. In addition, the data shows that 128,607 spouses and dependents (see Column B) of these employees are also receiving NJFC/Medicaid.

Of these 62,291 employees, 8,497 have private insurance (see Column F). "Traditional" Medicaid clients (funded under Title XIX of the federal Social Security Act of 1965) may have private insurance or third party liability (TPL). In these instances, Medicaid becomes the payer of last resort once the private coverage has reimbursed for allowable medical services.

Column D in the table shows there are 1,100 employees who are receiving services through the NJ Workability Program and are employed. NJ Workability offers full New Jersey Medicaid health coverage to people with disabilities who are working, and whose earnings would otherwise make them ineligible for Medicaid. Generally to be eligible for NJ Workability, a person must be between the ages of 16 and 64, working part time, full time or be self-employed, have a permanent disability and meet certain income and resource guidelines.

Also included in the data is information on government employers with 50 or more NJFC/Medicaid enrollees, of which there are 30. These 30 government employers employed 3,023 NJFC/Medicaid enrollees with 6,966 spouses or dependents at a total cost of \$6,747,583.92. The cost to New Jersey for these enrollees is \$ 2,884,880.89.

### **Cost to the State**

The total NJFC/Medicaid expenditures for private employees for the three month period from April 1, 2011 to June 30, 2011 were \$142,078,343.59 Of this \$101,681,089.50 was spent for Medicaid (Title XIX) coverage while \$36,514,604.76 was spent for NJFC (Title XXI) coverage. The remaining \$3,882,649.33 was for State-Only funded programs.

<sup>1</sup> Since March 1, 2010, NJFC/Medicaid may only accept applications from parents/guardians with work income at or below 133% of the federal poverty level. Prior to March 1, 2010, parent/guardians with any earnings up to 200% of FPL could be found eligible for NJFC/Medicaid.

In terms of state versus federal dollars for the same time period, the cost to New Jersey was \$44,682,277.51 for Title XIX Medicaid and \$12,780,111.67 for the Title XXI NJFC program.

While not specifically reflected in the data provided please note that for the same time period listed above \$4.9 million was paid in premium payments by families enrolled in the NJFC/Medicaid program. In addition, NJFC/Medicaid has a Premium Support Program which subsidizes employer-sponsored coverage by “buying in” to private coverage available to the NJFC/Medicaid enrollee when it is cost-effective to do so. In the second quarter of 2011 the savings to the State was \$80,537.95. Because the federal guidelines at the inception of the Premium Support Program required that health plans meet too high a standard it limited the number of plans that qualified and hence the number of enrollees in the program. Recently however, the NJFC/Medicaid program has submitted a revised formula and is awaiting formal approval by the federal Centers for Medicare and Medicaid Services. The new methodology is expected to substantially increase the number of participants in the program.

### **Comparison to 2010**

The number of NJFC/Medicaid enrollees employed by an employer with more than 50 employees increased by 11,807, or 23.4%. The total cost increased by \$38.2 million, or 36.8% primarily due to a \$27.3 million increase in Title XIX costs. The cost to the State increased by \$20.2 million or 49.0% partially due to a less favorable federal match. The American Recovery and Reinvestment Act of 2009 (ARRA) temporarily enhanced the federal match on Title XIX expenses from October 1, 2008 to June 30, 2011. New Jersey’s enhanced match decreased from 61.59% in March of 2010 to 56.88% in June of 2011.

### **Charity Care Information Submitted by the Department of Health**

The statute requires the Department of Health (DOH) to compile, to the extent data are available, information about employed recipients of Charity Care. Specifically, the law requests the following information: the employer’s name and address, the number of recipients on Charity Care who are employed by the employer; and the cost to the State of providing Charity Care for employer’s employees and their dependents.

DOH has reviewed the data submission process and supporting information technology structure and determined that this data is not available. In addition, as required by the “Charity Care Fraud Prevention and Detection Act,” DOH has reviewed, together with the Division of Taxation, the potential for file matching to ascertain the employer and wage data for Charity Care recipients. The results of the review indicated that the lack of a consistent identification number, such as a social security number, remains a significant impediment to compiling information about employed recipients of Charity Care.
