SUBJECT: ADMINISTRATIVE ORDER 2020-06

Today I signed Administrative Order 2020-06, which hereby orders as follows:

- 1. The expiration date of any valid New Jersey basic (Class "D") driver license, basic driver permit, non-driver ID, vehicle registration including any temporary or commercial vehicle registration, or vehicle inspection sticker, due for renewal between March 13, 2020 and August 31, 2020, is hereby extended as follows:
  - a. Expiration date March 13 through May 31, 2020, extended to September 30, 2020
  - b. Expiration date June 1 through August 31, 2020, extended to December 31, 2020

Please carefully read Administrative Order 2020-06 and be sure to note that the extension provided therein does not restore a driving or registration privilege that is subject to a valid order of suspension.

## **ADMINISTRATIVE ORDER 2020-06**

I, B. Sue Fulton, Chair and Chief Administrator of the New Jersey Motor Vehicle Commission ("MVC"), as authorized pursuant to Executive Order No. 103 (2020), the Motor Vehicle Security and Customer Service Act, N.J.S.A. 39:2A-1, et seq., N.J.S.A. 39:2-3, N.J.S.A. 39:2A-21, N.J.S.A. 39:3-4, N.J.S.A. 39:3-10, N.J.S.A. 39:3-10f, N.J.S.A.39:3-29.5, N.J.A.C. 13:18-11.9, N.J.A.C.13:20-43.12, and for good cause shown, do hereby order as follows:

- 1. The expiration date of any valid New Jersey basic (Class "D") driver license, basic driver permit, non-driver ID, vehicle registration including any temporary or commercial vehicle registration, or vehicle inspection sticker, due for renewal between March 13, 2020 and August 31, 2020, is hereby extended as follows:
  - a. Expiration date March 13 through May 31, 2020, extended to September 30, 2020
  - b. Expiration date June 1 through August 31, 2020, extended to December 31, 2020

Nothing in this Order shall be construed as restoring the driving or registration privilege of any person subject to an order of suspension or any suspension order imposed after the date of this Order.

Nothing in this Order shall be construed as permitting the operation of a motor vehicle without the automobile insurance required by law.

Nothing in this Order shall be construed as reducing the fee required to be paid upon renewal of any basic or commercial driver license or vehicle registration.

This order shall take effect July 15, 2020.
