SUBJECT:	Changes to Motor Vehicle Inspection Program Effective August 1, 2010

The New Jersey Motor Vehicle Commission will make changes to the Enhanced Motor Vehicle Inspection Maintenance Program, effective August 1, 2010. Most passenger vehicles will be required to submit for an inspection biennially (every two years) for emissions only. Commercial vehicles and buses will be required to be inspected annually (every year) for safety and the appropriate emissions test. Motorcycles will be exempt from inspection.

Further details about the Vehicle Inspection Program are listed in three charts below:

#### Chart 1: Passenger Vehicles

This chart includes all passenger vehicles that are plated passenger, not for profit (NF), governmental, commuter van (CV), farmer or farm truck.

## **Special Provisions**

- Any vehicle rejected for mechanical defects before August 1, 2010 will still be required to be repaired and
  pass a re-inspection at either a PIF or CIF before it can be issued a certificate of approval (inspection
  sticker).
- Any vehicle due for inspection prior to August 1, 2010 that is presented for an initial inspection after the law is enacted will only be given the required emission test.
- The regulations for the inspection of commercial and school buses remain unchanged.

### Dealer New Car Waiver Program

- All vehicles excluding taxis, limousines, jitneys, buses and commercially-registered vehicles will be issued a new vehicle inspection decal by a dealer or state representative valid for five (5) years from the month of registration expiring on the last day of that month.
- All vehicles less than five (5) model years old excluding taxis, limousines, jitneys, buses and commerciallyregistered vehicles will be issued a new vehicle inspection decal by a dealer or state representative valid for five (5) years from the vehicle's model year expiring on the last day of the month of registration.
- In order to retroactively implement the extension of the New Vehicle Waiver Program from four (4) to five (5) years, any vehicle with a new car inspection decal expiring after August 1, 2010 will be issued or mailed an extension decal by the MVC with the words "1-Year Extension" imprinted on it. Instructions will be provided to the motorist to display the decal above the inspection decal.
- It is important to note that vehicles with "New Car Dealer" inspection decals expiring in the months of August, September and October 2010 should not be issued a summons for "failure to inspect" due to the fact that the extension mailing process has just been implemented and the extension decals may not have been received by the motorist.

 All taxis, limousines, jitneys, commercial vehicles or buses that have been issued passenger, governmental, no fee, or commercial vehicle license plates not inspected by the MVC Commercial Bus Unit or School Bus Unit and purchased new, will be issued a "New Car Dealer Inspection Decal" by a dealer or state representative valid for one (1) year from the month of purchase expiring on the last day of that month.

Even with the enactment of these changes, motorists are still required to ensure that their vehicles are free from mechanical defects. A vehicle may be cited at any time for these defects or when equipment is out of compliance.
