schedule of violations and applicable penalties; N.J.A.C. 16:53A-4 pertains to evidence of insurance, and the penalties for fails to provide satisfactory evidence of appropriate insurance; N.A.C. 16:53A-5 pertains to sanctions for out-of-service violations; N.J.A.C. 16:53A-6 pertains to inspections, examination of driver pertains credentials, and certificates of inspection; N.J.A.C. 16:53A-7 pertains to vehicle inspection reports; and N.J.A.C. 16:53A-8 pertains to collection of penalties, including jurisdiction to morce penalty collection.

The Commission has captully considered these rules and has determined that the clipper remains necessary, proper, reasonable, efficient, understandable, and responsive to the purposes for which it was originally promagated, as amended and supplemented over time, and

should be adopted without amendment.

Therefore, pursuant to N.J.S.A. 52:14B-5.1.c(1), these rules are adopted and shall continue in effect for a seven-year period.

The New Jersey Rail Freight Assistance Program (RFAP) provides funding for capital improvements that result in the continuation of economically viable rail freight services. The existing chapter is summarized as follows:

Subchapter 1, Purpose and Scope, provides the purpose and scope of the chapter.

Subchapter 2, Definitions, provides the definitions for terms used throughout the chapter.

Subchapter 3, New Jersey Rail Freight Assistance Program, establishes the general provisions and requirements of the State Rail Freight Assistance Program.

Subchapter 4, Financial Assistance, provides guidelines for projects, financial assistance, and real property acquisition.

Subchapter 5, Project Application, Selection, and Agreement, provides the application process.

Subchapter 6, Annual Listing of Eligible Projects, provides the listing of eligible projects.

Subchapter 7, Audit, establishes audit provisions.
