Drainage improvements will eliminate flooding and icing conditions along this portion of Route 22. Six inlets will be added to the storm drainage system, three inlets each on the eastbound and westbound shoulders. These inlets will be connected to an 18 inch RCP that will link the new inlets to the existing drainage system. The existing 18 inch RCP between inlets will be replaced by a 24 inch RCP. All other existing pipes and inlets will remain unchanged. This improvements will mitigate the spread of stormwater in the 10-year storm event and have the capacity to convey stormwater runoff during the 25-year and smaller storm events.

This project will provide congestion mitigation in the Flemington area, from Route 202 east of Voorhees Corner Road to Route 31 north of Bartles Corner Road. Alternatives to be evaluated range from a 4-lane bypass with grade-separated interchanges to a 2-lane boulevard with at-grade intersections and a grid of streets providing connectivity.
