Here's what will change beginning May 12, 2023:

Vaccines

Good news. Just like other preventive health services, you will have no out-of-pocket costs for the COVID-19 vaccine and boosters when you use an in-network provider. The COVID-19 vaccine and boosters are still the best way to protect yourself from serious illness related to COVID-19.

COVID-19 Testing and Treatment

You will continue to have coverage for lab tests and treatment when received in network. However, you may have to pay your copay, deductible and/or coinsurance. If you have out-of-network coverage and use an out-of-network provider, you will pay more out of pocket.

Telemedicine

COVID-19-related care will be treated like any other telemedicine service. For in-network care, you will pay your copay, coinsurance and/or deductible. This includes services received through Horizon CareOnlineSM.
